



NEWPORT BERMUDA RACE 2014 AMENDMENT NO. 2 TO THE NOTICE OF RACE

The Notice of Race, dated February 1, 2014, is hereby **AMENDED** as follows:

- a.) 2.2 The Class Rules for yachts participating in designated one-design classes;
is DELETED for consistency with the Racing Rules of Sailing (“RRS”), which defines class rules;
- b.) **where the version-year 2014 appears with respect to rules and other documents, “2014” is REPLACED with “current” for clarification;**
- c.) 4.2(c) Captains shall be current members of their Member National Authority (“MNA”);
is DELETED as redundant or in conflict with RRS 75.1;
- d.) 6.2(e) x.) Inspection Checklist (completed).
is ADDED to the list of Required On Board Documentation;
- e.) **paragraph 5.3’s reference to “NoR 4.2(d)” is CORRECTED to “NoR 4.2(c)”;**
- f.) 9 The race will start in the vicinity of Castle Hill in Newport, Rhode Island, with a first warning signal scheduled for 1250, Friday, June 20, 2014.
is MODIFIED to remove the “Castle Hill” specification (although, if weather permits, the race will likely start near Castle Hill anyway);
- g.) 12.2 Decisions of the International Jury will be final in accordance with RRS 70.5.
is DELETED for consistency with RRS 70.5 (International Jury decisions are still final by default RRS);

- h.) 12.3 The International Jury may impose suitable penalties, which may include time penalties, for breaches of a rule. *See* NoR 8.8.
- is DELETED to avoid redundancy or conflict with NoR 2.6(c) and 8.8 (no substantive change to the race);**
- i.) **13.3, concerning Bermuda Check-In, is DELETED and REPLACED with:**
- 13.3 The Sailing Instructions shall require Captains to appear at Race Headquarters at Royal Bermuda Yacht Club and file a Certificate of Compliance after finishing.
- to avoid redundancy or conflict with the Sailing Instructions;**
- j.) 16.2 Scoring will be in accordance with RRS Appendix A.
- is DELETED as redundant or in conflict with RRS 90.3 (RRS Appendix A is still the scoring rule by default);**
- k.) **various additions have been made to accommodate the yacht *Spirit of Bermuda* in a Spirit of Tradition Division as was done in 2012; and**
- l.) **a few minor edits have been made for readability and paragraph enumeration in light of this amendment without substantive change to the race.**

A Notice of Race incorporating these amendments shall be published on the race website.
