1. The Club provides dining and bar facilities. Boats are required to bring their own anchors, lines, fenders and also shore power leads plus adaptors if they would like power. Shore power is 120v 30 amp or 120/240v 50 amp. We cannot guarantee that there will be a shore power outlet available for all boats due to the large number of boats in this event.
2. The charge for berthing, including water and use of the Club's facilities, is **\$4.50** per foot per day. Electricity use will be charged at **\$25/day**.
3. A **NON REFUNDABLE DEPOSIT of \$250.00** is required at the time of reservation. The deposit will be credited to the boat's account for expenses at the RBYC. Please note that the Berths will not be allocated if your credit card is declined or if we are given incorrect details at the time of booking.
4. The Club accepts no liability for damage of any sort to, or theft from, yachts using their facilities.
5. For Insurance purposes, all vessels moored at the Royal Bermuda Yacht Club Marina during the above event must vacate their allocated berths should a tropical storm warning be issued by the Bermuda Weather Service. The Organizers of the event will endeavor to provide alternate anchorage suggestions during this process.

In the event that your vessel is not removed, the owner will be held liable for any and all damage caused to the marina or any other vessel. The Club reserves the right to remove any vessel not so removed by the owner at the cost and risk to the owner.

The Club accepts no liability for damages of any sort as a result of the above.
